

Privacy Policy

Alsager Netball Club is committed to ensuring that personal information is held fairly, lawfully and securely in accordance with data protection laws.

This policy covers the different elements of personal information we collect from you, what we do with the information, how long we will hold it, what we won't do with the information, as well as what rights you have.

Introduction to Data Protection

We have an obligation under UK GDPR (Regulation (EU) 2016/679 of the European Parliament – the General Data Protection Regulation ('GDPR')) to provide you with information about how and why we use your data. We recognise our obligations and your legal rights set out in the GDPR. We are committed to protecting and respecting your privacy by complying with the principles of the GDPR.

Who are 'we'?

In this policy, whenever you see the words 'we', 'us' or 'our', it refers to Alsager Netball Club. We are the Club responsible for delivery of netball activities for our club members. Alsager Netball Club is the controller of all personal data processed by Alsager Netball Club

Data Protection Officer

Alsager Netball Club does not have a Data Protection Officer. However, for information and queries about data protection compliance, email: Alsagernetballinfo@gmail.com.

Amendments to our Privacy Policy

If we amend our privacy policy, any changes will be published on our website. If necessary, this will be brought to your attention.

What is personal data?

'Personal data' means any information relating to a living individual ('data subject') who can be identified, directly or indirectly by the information.

The types of personal data we may collect

The data we collect about you will vary, depending on our relationship with you. Below are examples of the sorts of data that we may collect:

- Full name and personal details (e.g. photograph, driving license, passport number);
- Contact information (e.g. home address, email address, telephone numbers);
- Date of birth and/or age;
- Special categories of data such as medical history (including details of any injuries or health conditions) or disability;
- Education and employment details
- Next of kin and emergency contact information;

- Imagery in video and/or photographic form and voice recordings;
- Criminal convictions and offences (where required for your role in the club);
- England Netball (EN) Affiliation Number and name of the EN affiliated Clubs with which you are registered
- Records of participation or attendance at events/sessions/competition;
- Relevant netball-related qualifications
- Records of enquiries and other correspondence with you;

We will only collect data that we need to carry out the services as Alsager Netball Club. If we don't need it, we don't collect it

How we use your personal information

We collect, store and process personal data for several purposes, mainly: administer your membership and provide the membership services you are signing up to when you register with Alsager Netball Club. This includes training, competition entry, social events, club management, information about external netball-related or sporting events and other activities directly related to your membership of Alsager Netball Club. We will not use any of the information that we collect from you, or about you, for any purpose other than those listed in this document or for purposes that are similar. If we would like to use your personal data in any other way, we will present you with relevant information at the point at which one of these additional purposes arises.

The GDPR provides that legally we might hold and process your information for any of the following four reasons and we have included below a summary of what that means for Alsager Netball Club and how we might use information you provide to us:

Where required to perform a **CONTRACT**. For example:

- To administer and manage our relationship with parents and members, including processing of membership forms and payments, membership renewals or invitations to social events
- To administer our relationship with people attending our club and to send them information about the club e.g. training times, match cancellation etc
- To administer attendance at competitions, events or training
- To fulfil our contractual relationship with sponsors and suppliers

Where required to comply with our **LEGAL OBLIGATIONS**. For example:

- To comply with health and safety requirements. For example, to ensure the safe running of netball sessions and to enable adaptations as required
- To comply with safeguarding requirements. For example, working with children or vulnerable adults
- To ensure we are offering equitable access to our club to avoid discrimination
- For the prevention of fraud and other criminal activities.

Where there is a **LEGITIMATE INTEREST.** For example:

To correspond and to answer queries and complaints.

- To create a better understanding of players and supporters you may process the personal data for the purposes of research.
- To arrange for any trips or transportation of officials, athletes or volunteers to events.
- To ensure understanding of the coaching, officiating and volunteering workforce available.
- To comply with awarding bodies' accreditation obligations.
- To administer and monitor attendance at events and competitions.

Where you have provided **CONSENT.** For example:

We may use and process your personal information where you have **consented** for us to do so for the following purposes:

- Processing your child's data for the purpose of their involvement in Alsager Netball
- Any special category health data we hold on you is only processed for the purpose of fitness/ health checks or passing health data to coaches and managers to allow the safe running of training sessions.
- Video/photographic for the purpose of player/team analysis and development or sharing on our webpage or social media
- Publishing of competition results and county achievements
- On occasions we may collect personal data from non-members e.g. such as any non-member participant who fills in a health disclaimer or form at a taster event. This information will be stored for 4 weeks after an event and then destroyed securely. Our lawful basis for processing data is consent. Therefore, we will need explicit consent from non-members to process this data, which we will ask for at the point of collection.

Retaining your information

If we collect your personal information, the length of time that we retain it is determined by a number of factors, including the purpose for which we use that information and to comply with our other legal obligations (apart from GDPR). We maintain a Retention Schedule, which records approved retention periods, the reasoning for the retention period and end of life treatment.

We will hold information about you in our data systems (Alsager Netball Club's Google Account) only for as long as we need it for the purpose for which we collected it. We will hold your personal data on file for as long as you are a member with us. Members' data is updated every year on annual membership forms. Any personal data we hold on you will be securely destroyed after four years of inactivity. Your data is not processed for any further purposes other than those detailed in this policy.

We do not retain personal information in an identifiable format for longer than is necessary. Where you have consented for us to retain your data, we will only hold the data for the duration of your consent.

Children

Children's data are collected and processed in accordance with the information below. Parents and guardians are expected to ensure that the children they are responsible for are aware of how their personal data will be processed by us.

We require parental or guardian consent to process personal data of any child under the age of 14.

Using your information for marketing

Alsager Netball Club only sends out / forwards selected communications from third parties which may include courses, training opportunities, competitions/matches, event tickets as part of your membership package, where this is relevant to your membership of Alsager Netball Club.

We only send marketing information to you if you have explicitly agreed to our doing so or have requested it and we will only do so in the way(s) you have agreed to. See below for more information.

Withdrawing consent

Sharing your personal data and data processing

We only share personal data where we are required by law or with our suppliers or subcontractors who carry out work for us and who you have given us permission to share it with. Other than the circumstances set out above, information about you will not be passed to a third party for any other purposes. All our suppliers and sub-contractors are required by their own data sharing agreements or contracts to treat your data as carefully as we would, to use it only as instructed, and to allow us to check that they do this.

Organisations we share your personal data with

- All England Netball Association
- County Netball Associations for training sessions, matches and events
- Regional Netball Associations and leagues and other competition providers for matches and events
- Where the law requires it. We may disclose your personal information to third parties
 if we are under a duty to comply with any legal obligation; to enforce or apply our terms
 of use and other agreements; or to protect the rights, property, or safety of your
 customers, or others, including exchanging information with other companies and
 organisations for the purposes of fraud protection and credit risk reduction Anyone
 else where you have the data subject's consent.
- Companies, sub-contractors and other persons who help to provide our courses, training programmes, matches or events (e.g. Leisure centres / venues where training or matches/events are run);
- Funding partner(s) as condition of grant funding, e.g. Local Authority (anonymised data)

Profiling

Alsager Netball Club does not perform any profiling that has legal or significant effect nor any automated decision making.

International transfer

The personal information we collect may be transferred to and stored in countries outside of the UK and the European Union. Some of these jurisdictions require different levels of protection in respect of personal information and, in certain instances, the laws in those countries may be less protective than the jurisdiction you are resident. We will take all reasonable steps to ensure that your personal information is used only in accordance with this privacy notice and applicable data protection laws and is respected and kept secure. Where a third party processes your data on our behalf we will put in place appropriate safeguards as required under data protection laws.

Information Security

Alsager Netball Club has the following social media pages: Website, Facebook, WhatsApp & Twitter. All members are free to follow / join these pages. If you join / follow one of the Social Media pages, please note that providers of the social media platforms have their own privacy policies and that Alsager Netball Club does not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages. Inappropriate use could result in your membership being suspended/cancelled.

We do our very best to keep personal information secure wherever we collect personal data online. We place a great importance on the security of all personally identifiable information associated with our members. We will take all steps reasonably necessary including policies, procedures and security features to ensure that information about you is treated securely and protected from unauthorised and unlawful access and used in accordance with this privacy policy. We have security measures in place to attempt to protect against the loss, misuse and alteration of personal data under our control or being transferred, we use our best efforts to try to prevent this.

Our website, messaging services (including <u>WhatsApp</u> and <u>Teamer</u>) and social media (including <u>Facebook</u>, <u>Twitter</u> and <u>Teamer</u>) pages may, from time to time, contain links to and from the websites of third parties. If you follow a link to any of these websites, please note that these websites have their own privacy policies and that we do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data to these websites.

What we don't do with your information

We never sell or share your information with other organisations to use for their own purposes.

Your rights

The GDPR grants you certain rights ('information rights') which we summarise below.

Right of access	You have the right to obtain confirmation from Alsager Netball Club as to whether or not personal data concerning you are being processed, and, where that is the case, you have the right to access that personal data.
Right to rectification	You have the right to oblige Alsager Netball Club to rectify inaccurate personal data concerning you. Taking into account the purposes of the processing, you have the right to have incomplete personal data completed by providing a supplementary statement.
Right to erasure (right to be forgotten)	You have the right (under certain circumstances, but not all) to oblige Alsager Netball Club to erase personal data concerning you.
Right to restriction of processing	You have the right (under certain circumstances, but not all) to oblige Alsager Netball Club to restrict processing of your personal data. For example, you may request this if you are contesting the accuracy of personal data held about you.
Right to data portability	You have the right (under certain circumstances, but not all) to oblige Alsager Netball Club to provide you with the personal data about you which you have provided to Alsager Netball Club in a structured, commonly used and machine-readable format. You also have the right to oblige Alsager Netball Club to
	transmit the data to another controller.
Right to withdraw consent	If the lawful basis for processing is consent, you have the right to withdraw that consent.
Right to object to direct marketing	Where your personal data are processed for direct marketing purposes, you have the right to object at any time to processing of your personal data for marketing, which includes profiling to the extent that it is related to such direct marketing.
Rights in relation to automated decision making and profiling	Alsager Netball Club does not perform any automated decision- making based on personal data that produces legal effects or similarly significantly affects you.
